



Waiver/Release of liability

By agreeing to this waiver, you will waive certain legal rights, including the right to sue. Please read this agreement carefully.

- 1) I am fully aware of the risks and hazards inherent to the participation of yoga classes and/or other activities offered by and/or taking place on the premises of **Pawsome Yoga (hereinafter "Pawsome Yoga")** and/or offsite. Collectively all activities offered by and/or taking place on the premises of Pawsome Yoga and/or offsite, whether specifically enumerated herein or not, will be referred to as the Activities. The Activities may require physical exertion and may result in me being physically adjusted and/or touched by agents of Pawsome Yoga.

The Activities may be strenuous, dangerous and participating in the activities could cause physical injury. I am fully aware of the risks, dangers and hazards involved with all The Activities in which I chose to participate and have consulted with a physician prior to participating in The Activities. I understand none of The Activities are medical in nature and are not suitable for medical examinations or procedures. I represent and warrant that I am physically capable of and have no medical conditions preventing me from participating in The Activities.

Any behaviour deemed inappropriate by Pawsome Yoga shall result in immediate termination of the Activity but shall not relieve my obligation to fully pay Pawsome Yoga for the activity. Pawsome Yoga reserves the right to refuse to allow me to participate in any Activity for any reason deemed appropriate by Pawsome Yoga.

- 2) In consideration for being allowed to participate in the Activities, I assume all risk of injury, illness, death, damage or loss to person or property, whether economic or noneconomic, related in any way to the Activities. I agree to indemnify and hold harmless Pawsome Yoga and its agents, employees, officers, members, contractors, instructors, successors and assigns from any and all claims, demands, debts, causes of actions and liability, of every kind, whether known or unknown, arising in any way from the Activities.

In further consideration of being allowed to participate in the Activities, I forever release and discharge Pawsome Yoga and its agents, employees, officers, members, contractors, instructors, successors and assigns from any and all claims, demands, debts, causes of actions and liability, of every kind, whether known or unknown, arising from or related to in any way to the Activities, including but not limited to, any such claims, demands, debts, cause of action or liabilities arising from the alleged negligence of Pawsome Yoga.

- 3) Neither Pawsome Yoga nor its agents, employees, officers, members, contractors, instructors have made any representation concerning the nature and dangers associated with the Activities other than what is stated herein. This release and waiver of liability contains the entire agreement between the parties and supersedes any prior written or oral agreements concerning the subject matter herein and cannot be modified, waived or terminated within the written consent of Pawsome Yoga.
